Beach Patrol Committee

David Taylor has resigned from the chairmanship of this Committee. He will focus his time and efforts on family this year. We are very grateful for his leadership for many years. Margie and Steve Larson met with Justin on February 8, 2020. Justin came prepared with the draft of a proposed pay scale reflecting incremental hourly rate increases based on years of service with MBA Lifeguard service; a list of uniform needs; 2020 certification needs; equipment needs; and suggested dates for beach programs for 2020. It was a very productive meeting; and Justin expressed thanks for being included. Steve will use the recommendations as his Budget Committee continues to work on the budget. Margie has discussed committee challenges and opportunities; and potential committee leadership individually with each member of the Beach Committee. Recommendations from these conversations were consistent. The appointment of a new Committee chairman will be on the Board's agenda.

Community Facilities Committee

- Bridge Road Fence Damage
 - Posts were replaced and new boards install the weekend of 11/02/2019.
 - We are looking to find a supplier of the 3"x6" boards to make the mid rail match the existing wood.
 - No new update.
- Dune Fencing
 - Installation completed on North/South run. Installation continues North and South Dune.
- 11 Bayberry Culvert Work
 - Legal agreement needs to be completed.
- 18 Bayberry Culvert Work
 - New pipe has been installed; final gravel completed.
- 27 Errett Driveway Extension Request
 - Scheduling is in progress for new culvert and swale repair.
- Polaris Repairs
 - Repairs complete

Future Projects

- Creak sealing for beach Streets
 - Should be performed in the spring once temperatures rise above 50 degrees.
 - Sealer is \$10 a gallon, would need approximately 60 gallons to complete the crack filling.
- 4th of July Lighting Project
 - Lighting decisions approved in January (5 lights with built in generators for the fourth). Update from request to DelDOT will be discussed.
- Route 1 State Lighting Project
 - No new update at this time.
- Bayberry Enclosure Fence (North Side)
 - Margie and Alex met with the owner at 1 Bayberry to discuss replacing the fence between her property and the storage space. The Board needs to approve this project.
- Landscaping Contract
 - Tris and Alex met with the three landscaping bidders on 2/15/20 to review the needs for beautification and the maintenance contract. It was decided that
